

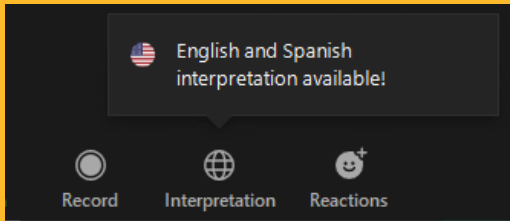

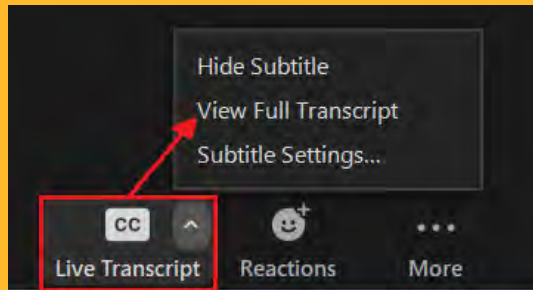

American Rescue Plan Act (ARPA) Overview

On March 11, 2021, ARPA was signed into law, which provides \$350 billion in additional funding for state and local governments to do the following:

- support public health expenditures by funding COVID-19 mitigation efforts
- address negative economic impacts, including economic harms to workers, households, small businesses, industry and public sector
- serve the hardest hit communities and families
- replace lost public sector revenue to the extent due to the pandemic
- provide premium pay for essential workers
- invest in water, sewer, or broadband infrastructure



U.S. Treasury Department Funding Priorities

“To promote and streamline the provision of assistance to individuals and communities in greatest need, particularly communities that have been historically disadvantaged and have experienced disproportionate impacts of the COVID-19 crisis.”

Alameda County Board of Supervisors Priorities

Allocate \$162.0M ARPA funding (one-half of the \$324.0M allocated to Alameda County) as follows:

- \$50.0M to the Alameda County Health Care Services Agency (**HCSA**) for the continued provision of COVID testing, contact tracing, vaccination, and other needed COVID mitigation services;
- \$50.0M to the Alameda County Social Services Agency (**SSA**) for the continued provision of emergency food and other basic needs countywide;
- \$14.0M to highly impacted communities, families and businesses in the urban **unincorporated** parts of Alameda County;
- \$48.0M to highly impacted communities, families and businesses **throughout Alameda County** in the following targeted ways:
 1. **Capacity Development** (\$10.0M) – using Community Capacity Fund model, funds will be used for general operating support for CBOs.
 2. **Outreach & Navigation** (\$5.0M) – based on population need as determined by COVID-19 impacts, funds for a community-based navigator program will target the most impacted areas to connect families with existing resources.
 3. **Economic Development** (\$10.0M) – with city participation, grants for businesses will support workforce development, job creation or TA provided through the Chambers of Commerce.
 4. **Community Needs Grants** (\$23.0M) – grants will be provided to support identified community needs: childcare, senior services, ARCH stipends, arts, physical infrastructure, etc.



Alameda County Board of Supervisors Priorities

Of the first \$162M to be spent, **\$11M** will go to:

- **\$6M for Capacity Development to expand on HCSA's Community Coalition Contracts** (*\$4M will be administered by SSA*)
- **\$5M for Outreach & Navigation to expand HCSA's Community Coalition Contracts**
