COVID-19 Vaccinations at the Alameda County Fairgrounds to Move Operations to Stanford Health Care – ValleyCare and Sutter Health’s Campuses

PLEASANTON, CA – Alameda County, Stanford Health Care – ValleyCare and Sutter Health announced today that appointments for COVID-19 vaccinations, previously offered at the Alameda County Fairgrounds in Pleasanton, will relocate to the medical providers’ respective campuses.

Since opening in mid-February, Alameda County, Stanford Health Care – ValleyCare and Sutter Health have administered 140,000 vaccine doses at the Fairgrounds to over 75,000 people. Two-thirds of all doses were received by 50,000 Alameda County residents.

“This site has been an important part of Alameda County’s vaccine strategy. As the County Supervisor representing Pleasanton, I appreciate the extraordinary impact this incredible partnership has had,” said Alameda County Supervisor Nate Miley. “Together we have quickly vaccinated thousands of seniors, essential works, and residents 12 and older.”

Stanford Health Care – ValleyCare and Sutter Health will offer first and second dose vaccination appointments at their regular care sites; second dose appointments will be available at those sites after the Fairgrounds’ services close.

On May 26, Stanford Health Care – ValleyCare will complete its scheduled appointments at the Fairgrounds and then transition to its Livermore walk-in clinic on June 1. The site will be operated by Stanford Health Care – ValleyCare (SCH-VC) for adult appointments, and Lucile Packard Children’s Hospital (LPCH) for 12-17-year-olds.

- **Second location at Stanford Health Care, Emeryville:** Sunday – Thursday, from 12 am - 8 pm
- Appointments will be available 7 days a week between both sites across Alameda County.

Sutter Health

On May 24, Sutter transitioned from the Fairgrounds while continuing to offer vaccination at several locations, including walk-in care clinics throughout the County and Northern California. Patients may schedule a COVID-19 vaccination appointment online or by phone:

- Online: Patients can log into **My Health Online (MHO)** to schedule an appointment. If they don’t have an account, they can enroll in-person at their provider’s office or by calling a MHO service representative at (866) 978-8837. Parents or guardians with proxy access to their child’s My Health Online account will be able to help schedule their teen’s COVID-19 vaccination appointment. However, once the appointment is scheduled, the details will only be visible to the teen in their own account.

Alameda County residents, 12 and older, can access appointments through their health care provider, a local pharmacy (visit MyTurn.CA.GOV), or dropping in to County-supported Community Points of Dispensing (pre-registration is encouraged: call 510-208-4829 or visit bit.ly/AICoSignUp).

Parents or guardians of children 12 and older are encouraged to have them vaccinated. Children are eligible to receive the Pfizer COVID-19 vaccine, which clinical trials show is safe and effective.
