Alameda County Health Care Services Agency Update

This is National Public Health Week and wish to recognize and thank public health workers across Alameda County. Our Agency centers its work on the health of our community and how social determinants of health - the conditions in places where people live, learn, work, and play - affect a wide range of health and quality-of-life risks and outcomes. Our mission to improve the health of Alameda County remains more critical and relevant than ever.

We ask our community to remain vigilant in managing COVID risk. Vaccines and boosters remain the best protection against severe disease along with other precautions. Preventions are especially important as students return from spring break to Alameda County schools. (See Reminder to Test Before Returning to School.)

Last week the Centers for Disease Control and Prevention, the California Department of Public Health (CDPH) and the Western States Scientific Safety Review (WSSSR) recommended additional boosters for individuals over the age of 50 and people who are immunosuppressed. (See Second Booster for 50+ and Immunocompromised.)

The state lifted the guidance for indoor mega-events last Friday, April 1. Alameda County continues to align with the state, moving from vaccine verification or proof of negative test requirements in these settings to strong recommendations.

As we move into the third year of COVID response, we are mindful of the impacts to mental health caused by the pandemic over the last two years. The interventions that slowed the spread of COVID-19 contributed to feelings of isolation and exacerbated existing mental health challenges. Taking steps to cope in healthy ways like exercising or meditating can help. We remind the community that it's ok not to feel ok and to seek support from a mental health professional whenever needed.

We appreciate your time and support in helping us maintain a safe and healthy Alameda County. Help us distribute this information to others by sharing this newsletter.

Listening Session American Rescue Plan Act (ARPA)

The Alameda County Board of Supervisors approved the use of ARPA funds to build on our Agency's recently launched community coalitions. We remain mindful of and thankful for the coalition model championed by former Supervisor Wilma Chan.

Second Booster for 50 + and Immunocompromised

Alameda County supports <u>recommendations</u> for a second booster for everyone 50+, severely immune-compromised people 12+, and all Johnson & Johnson vaccine recipients who have already had one booster dose, but they are not yet authorized for other populations. Contact your health care provider or local chain pharmacy for your booster. Second boosters are available to eligible populations at County supported sites. We continue to prioritize the unvaccinated, immunocompromised, and first boosters for



appointments. Second booster doses are only available on a walk-up basis.

In-Home COVID-19 Vaccine



A team of nurses can bring the COVID-19 vaccine to your doorstep. In-home vaccination is available for homebound, people with disabilities, and groups of 3+ persons living in priority zip codes. Translations services are available. For appointments call (510) 208-4829 (4VAX), text VAX to (855) 315-1373, or register online.


Reminder to Test Before Returning to School After Spring Break



Alameda County and the California Department of Public Health (CDPH) encourage parents and guardians for all school-aged children to access athome COVID-19 kits as students return to school following spring break. The State of California distributed free COVID testing kits to school districts for students to prevent COVID from


entering schools following spring break and possible travel. Prepare for a safe return after spring break by sharing test results via the Primary.Health link sent by the school. If you did not receive a schoollink, report results via the Primary.Health website. Students should test 1 to 3 days before returning to school and follow up with their school if further guidance is needed.

Monitoring Wastewater, Variants, and Masking



We continue monitoring COVID-19 levels in local wastewater. As of March 31, the East Bay MUD COVID wastewater signal remains low and stable. Most publicly available wastewater data for California looks similar, although some neighboring jurisdictions have posted small increases in some sewer sheds.

The BA.2 wave that impacted some European countries is receding. BA.2 is the dominant COVID variant in the US and represents an estimated 75% of strains in the West, but pre-existing immunity may be sufficient to prevent a major wave of BA.2 here. BA.2 strain dominance by itself is not sufficient to cause a wave. We should expect ongoing cases, hospitalizations, and sporadic outbreaks but the timing of future waves remains uncertain. A substantial



new wave of infections may require the reintroduction of a countywide masking requirement. Such a requirement would be a short-term measure to avert the worst impacts of a wave and would provide the greatest benefit if implemented before a wave peaks. It would be lifted with limited impacts from severe disease or by using the CDC COVID Community Level criteria. A combination of data inputs will be useful when considering such a measure including case and wastewater data, conditions in highly impacted neighborhoods and neighboring jurisdictions, and the degree of severity in local cases if known.

Epidemic Data Points (7-day lag)

- 6.9 cases per 100,000 residents per day total population
- 6.0 cases per 100,000 residents per day fully vaccinated
- 12.8 cases per 100,000 residents per day unvaccinated
- 50 hospitalized, 3 in ICU
