Notes:

1. What do you want us to see accomplished moving forward?

- a. Diversify our messaging toward chronic conditions. Diversity of our community dictates that strategy. COVID has given us an opportunity to connect.
- b. Like to see how we can coordinate these groups together to target specific communities and health challenges as a coalition (example: childhood obesity). How can we pool all of our talent and resources together to make meaningful change?
- c. Agree with point B. The great opportunity we've had has been build a diverse group of organizations to deal with both crises that arise and normal, long-term struggles.
- d. Echoing Point B w/ additional thoughts: one positive outcome of the covid experience has been more of an opportunity for the healthcare and social services network at large to collaborate with the public health organizations. At times, it can be challenging to understand which groups/orgs are focusing on social services and which are focusing more on healthcare services.
- e. Let's not lose all this infrastructure that has been built and let's apply it to other things! As we are finding out about the commercialization of the covid response topics, let's make it as smoothly as possible and not overestimate that the system is ready for that.
- f. In communities of color, the levels of service are diminished. And data accuracy--how can we bring inequities to the forefront?

2. What models do you see moving and what relationship do you want to see?

- a. Enrollment and re-determination for Medi-Cal needs to be better streamlined and with better safety nets. We need to prevent people falling off of enrollment. Big issue with children not being up to date with their vaccines. Lots of disinformation affecting outcomes.
- b. We need to be concerned about mental health, the mental health care system, and the mental health of children. For models, my group has utilized a living document so that new ideas can be added and expanded on a rolling basis, and allows any and all to see ideas, input, concerns, and thoughts.
- c. Infrastructure is key. With COVID, people hit the ground running and people were moved around to respond. Funding for a response like this is not something that exists always. If there is no place for coalition work like this to exist, it will exist in the form of a meeting or a document, but it won't sit as a part of the organization chart or structure. What is the structure of the PHD that could allow us to land in a place that allows us to meet challenges? The public hospital system, Alameda Alliance, and FQHCs it would be great to see these important partners engaged in this coalition.

 - Groups like this start off well but attention goes to creating with the system that needs to be changed. Structure of meeting is changed, and they [general community members] get shut out. Unable to provide input. Starts from "us" and then shifts to community members being talking at.
 - In the beginning we were thrown in a sink or swim situation, lost the "us" with the community. 18-25 year old group has been missed out in conversations, same with adolescents. Need to involve the communities we have the hardest time reaching (high covid positivity rate, low vax rate)
 - \circ $\;$ Think about the communities that are missing then thinking about the "us".
- 2. What models do you see for us working together going forward? What type of relationship do you want to see?
 - Getting groups together can be hard sometimes but can be easy when going into the community. Smaller groups of teams. Asking community members if they want to be part of this, in sections where they live. Don't want to be overwhelmed such as feeling the county won't listen.
 - Smaller geographically focused group.
 - Feedback of community members not seeing what is being implemented, what is the point of attending? Most people here are being paid to be here.
 - Help us, help you. Tell us.
